

Sussex NHS & Carers Wedding Competition

Terms and conditions of entry

The Promotor:

The following terms and conditions apply to this competition being run by The Sussex NHS Wedding and Carers Competition Wedding Team collectively known as the '**The Sussex Wedding Team**' whom are acting together for the purpose of this giveaway form a 'not for profit' group.

The Competition:

The lucky couple, whether that is you and your partner or someone that you nominate ("the entrant") that wins the gifted wedding worth up to £30K will get married on 30th September 2021 at Cottessmore Hotel Golf and Country Club.

The Competition opens on 1st June 2020 and closes on 31st July 2020.

These terms and conditions set out the basis on which the entrant can participate or nominate a couple deserving of winning the Sussex NHS & Carers Wedding Competition. By entering the Competition, you and your partner are deemed to accept these Terms and Conditions in full. If you and or your partner do not accept any or all of these Terms and Conditions, you should not enter the Competition and you or anyone you have nominated will not be eligible to win the Prize.

There is no cash alternative to this prize offered and **all involved Suppliers of wedding services will have their own terms and condition that you will be expected to agree to**. A list of the Suppliers and what they will provide the winning couple with on their special day is available at the end of these terms and conditions at Schedule 1. Suppliers will contact the winning couple directly once the winning couple has been announced.

Prize: Persons who meet the criteria as detailed in 1.1 to 1.5 of the **Conditions of Entry** below are eligible to enter this Competition to win their entire wedding day.

How to enter:

The Competition will run from **8pm on 1st June 2020** (the "**Opening Date**") to **Midnight on 31st July 2020** (the "**Closing Date**") inclusive.

All Competition entries must be received by the Sussex Wedding Team by no later than Midnight on the Closing Date. All Competition entries received after the Closing Date are automatically disqualified.

You can enter the Competition online by completing the online entry form on our website and submitting the online entry form by the Closing Date.

The Sussex Wedding Team reserves the right to hold void, suspend, cancel, or amend the Competition where it becomes necessary to do so.

We may from time to time change these Terms and Conditions without giving you notice but we will use our reasonable endeavors to inform you as soon as is reasonably possible of any such change. This will usually be by updating the terms on our website and advising the same via social media.

Conditions of Entry

To enter the competition, you and your partner or your nominee must be able to provide proof of eligibility. In particular you and your partner or your nominee must:

- 1.1 be over the age of 18 and each be legally entitled to marry; and
- 1.2 not already be a married couple. The Competition does not cover 'renewal of vow' ceremonies or celebrations
- 1.3 Entries are restricted to entrants or nominees from the following sectors:
 - One of the entrants must be employed by one of the following NHS Trusts at the time of this competition or contracted to transfer to one of the following NHS Trusts at the time of this Competition:
 - Sussex Partnership NHS Foundation Trust
 - Sussex Community NHS Foundation Trust
 - East Sussex Healthcare NHS Trust
 - Western Sussex Hospitals NHS Foundation Trust
 - Brighton and Sussex University Hospitals NHS Trust
 - Surrey and Sussex Healthcare NHS Trust
 - anyone who is currently contracted to work for the NHS, for example, nurse, cleaner, cook, pharmacist, etc and they must provide evidence of their current employment or contract with the NHS at the time of this Competition;
 - anyone who is employed by any of one the District or Borough Councils within Sussex;
 - anyone who works for any recognised Care Service provider or care-based Charity within the Sussex County.
- 1.4 The entrant is required to provide proof of employment from one of the applicable sectors ideally by way of their work place photographic ID clearly showing the entrant's full name and occupation. If photographic ID is not available then some other form of proof will be required. The ID will be requested and approved at the shortlist stage of the Competition.
- 1.5 Entry is open to persons who live in the County of Sussex or within a 30-mile radius of the border of the County of Sussex and satisfies one of the above employment criteria in clause 1.3.
- 1.6 **Entry is not open to:**
 - 1.6.1 employees of the Sussex Wedding Team or its Suppliers;
 - 1.6.2 employees of agents or Suppliers of the Sussex Wedding Team who are professionally connected with the Competition or its administration; or
 - 1.6.3 members of the immediate families or households of (a) and (b) above.
- 1.7 If you or your nominee has already booked your wedding at Cottesmore, Hotel Golf and Country Club you are unable to enter this Competition.
- 1.8 If the winning couple has paid a deposit to any of the Sussex Wedding Team Suppliers these deposits are non-refundable and any bookings are non-transferable.
- 1.9 By entering or nominating someone into the Competition, you hereby warrant that all information submitted by you on their behalf is true, current and complete.
- 1.10 If you are nominating someone into the Competition you hereby agree that you have sought their permission to nominate and that all information that you have been provided is true, current and complete.
- 1.11 To enter this competition, the winning couple must be available to receive this wedding package on Thursday 30th September 2021. This is not transferable due to the availability of the Suppliers.

- 1.12 The winning couple and their wedding guests must be willing to travel to Crawley for the wedding which will take place at Cottesmore Hotel Golf and Country Club, Buchan Hill, Pease Pottage, Crawley, West Sussex, RH11 9AT.
- 1.13 In order for the ceremony to take place the winning couple must be legally married before 30th September 2021. The wedding won in this competition is conducted by a celebrant and therefore not a legally binding ceremony. Evidence in the form of a marriage certificate will therefore be required. Failure to comply with this term will result in the entire prize being withdrawn.
- 1.14 The winning couple are solely in charge of costs incurred by registrar, notice of marriage and wedding insurance.
- 1.15 All Suppliers have confirmed their availability for the above date and willingness to take part.
- 1.16 If for any reason the wedding is delayed a new date will be agreed based on the availability of the venue and Suppliers. No Supplier is held accountable if they are unable to commit to the new wedding date however all reasonable efforts will be made to find a suitable replacement if necessary.
- 1.17 Any additional requests resulting in additional costs by the winning couple from any Suppliers must be discussed directly with them. These additional costs are responsibility of the winning couple payable direct to the Supplier.
- 1.18 The winning couple is allowed to invite up to 50 guests to the wedding. You are welcome to increase the number of guests to your wedding if you pay for those additional people. Please discuss this directly with Cottesmore Hotel Golf and Country Club & all relevant Suppliers. The Cottesmore Hotel Golf and Country Club can cater for up to 150 sit down guests (100 more than the 50 guests paid for by the Competition) and an additional 50 for the evening (i.e. 200 maximum). In the event that the winning couple would like to have a buffet at the evening reception this will need to be funded by the winning couple
- 1.19 All professional images and videos taken by Daniel Thomas Photography, Imogen Eve Photography and Neil Collins Films along with any photographs taken by any of the Sussex Wedding Team may be used by the Suppliers named in Schedule 1, for advertising and marketing purposes across social media, individual websites and promotional materials. By entering the Competition, the winning couple consents to these images being used.
- 1.20 The Suppliers will short list based on the information provided by the entrants on the online entry form. The form is your opportunity to tell us something about yourselves, or the person nominated and to explain why they are being nominated, and the shortlist will be based on this information. The shortlist will then go into the random draw using **www.random.org**. Due to the current isolation rules imposed by the government, Suppliers are unable to specify the date on which the shortlist of entrants and nominated couples will be created. However, it will be done as soon as practical once any C-19 related restrictions have been lifted.
- a. The shortlisted entrants and their nominated couples will be drawn at random using **www.random.org** and the winning couple will be announced on BBC Radio Sussex. The winning couple must make every effort to be available to speak with the radio hosts when their names are announced.
 - b. All updates regarding this will be communicated on the website **www.sussexnhscompetition.co.uk** and across social media.
 - c. If the winning couple wish to not accept this prize, they will need to let The Sussex NHS & Carers Competition Team know within 48 hours of being notified of their win. A new winning couple will then be selected.

- d. If the winning couple decide to decline the prize within 48 hours of the announcement on BBC Radio Sussex, they forfeit any rights to any part of the prize and cannot change their mind at a later time.
- e. All of the Suppliers involved have invested their time into this Competition therefore all of the Suppliers named in Schedule 1 must be used as individually described in that Schedule 1 and not be disregarded based on the individual taste of the winning couple.
- f. This Competition is offered in good faith and all reasonable steps have been taken to ensure the Competition runs smoothly; however, in the event of any dispute The Sussex NHS & Carers Wedding Competition judges' decision is final.
- g. Any meetings prior to the wedding with any of the above Suppliers will be at such location as specified by the Suppliers or take place online where required or more appropriate.
- h. By entering the Competition, you agree for the wedding to be promoted on all Suppliers websites, social media and any other form of advertising including the press/ media.
- i. By entering this Competition – in line with GDPR you agree to the Suppliers contacting you in relation to this Competition.
- j. It is suggested that all those entering the Competition will follow all of the Sussex Wedding Team on social media however this is not a requirement of entry.
- k. The competition is in no way affiliated to any social media platforms, although advertised on Facebook, Twitter, and Instagram
- l. The Competition winner is to be announced and advertised in partnership with BBC Radio Sussex.

1.21 No purchase is necessary and there is no charge to register for use of the website.

1.22 The Sussex Wedding Team will **not** accept:

- (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
- (b) proof of transmission as proof of receipt of entry to the Competition.

1.24 The competition entries will be judged by The Sussex Wedding Team. The decision of the panel of judges (acting reasonably) will be final.

1.25 The Sussex Wedding Team will not accept Competition entries that are:

- 1.25.1 automatically generated by computer;
- 1.25.2 illegible, have been altered, reconstructed, forged or tampered with; or
- 1.25.3 incomplete.

1.26 There is a limit of one entry to the Competition per person. You may however nominate more than one person but you must not nominate the same person more than once.

1.27 The Sussex Wedding Team reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize Competition.

1.28 The decision of the Sussex Wedding Team is final and no correspondence or discussion will be entered into.

- 1.29 The Sussex Wedding Team will contact the winner personally as soon as practicable after the Announcement Date, using the telephone number or email address provided with the Competition entry.
- 1.30 The Sussex Wedding Team must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Sussex Wedding Team will publish the surname and where appropriate the occupation of the winning couple at a date to be confirmed after the Closing Date of the Competition.
- 1.31 If you object to any of your details being published or made available, please contact the Sussex Wedding Team sussexnhsandcarersweddingcomp@gmail.com. In such circumstances, the Sussex Wedding Team must still provide the information and winning entry to the Advertising Standards Authority on request.
- 1.32 The Sussex Wedding Team will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available the Sussex Wedding Team reserves the right to offer the prize to the next eligible entrant selected from the shortlist.
- 1.33 The Sussex Wedding Team does not accept any responsibility if you are not able to take up the prize.
- 1.34 **Exclusivity**: It is understood that the Sussex Wedding Team will act as the sole and exclusive Suppliers for your wedding with regards to their individual services. By agreeing to these terms and conditions, the winning couple agrees that no other person, company, professional or otherwise, shall provide products or services for the wedding without the consent of the Sussex Wedding Team. For example, if additional hair services are required, it is understood that Occasion Hair by Megan will provide the entire hair dressing service, similarly all furniture would be supplied by Boho & Bloom Prop Hire, and so on. This clause is to protect the image of the Suppliers from any assumptions that might arise about the quality of the Suppliers' services by the wedding's attendees.
- 1.35 **Limitation of liability**: Insofar as is permitted by law, the Sussex Wedding Team, its Suppliers, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Sussex Wedding Team, its agents or distributors or that of their employees. Your statutory rights are not affected.
- 1.36 **Insurances**: All Suppliers of the Sussex Wedding Team hold their own insurance, individual and specific to their business. If you wish to discuss any specific concerns, please speak to the individual Supplier to see a copy of their insurance policy. The winning couple is recommended to take out their own wedding insurance policy to cover events such as postponement or cancellation.
- 1.37 **Cancellations, postponements and force majeure**: Whilst all Suppliers will make every effort to ensure that the wedding services agreed between the various Suppliers and the winning couple are fully operational and error-free, we cannot guarantee this. Acts of God (also known as **force majeure** as defined below in point 1.39) "events" out of the control of the parties and therefore beyond our reasonable control, including sudden ill health and adverse weather conditions, may affect our ability to deliver the wedding on the 30th September 2021 or at all. We therefore cannot accept any liability for the postponement or cancellation of your wedding. If any of the Sussex Wedding Team are prevented from providing the wedding services or products as agreed under this clause then they cannot be held individually or collectively accountable,

however, they have all agreed to do all that is reasonably possible to find a replacement if that would assist with the wedding going ahead.

1.38 If the wedding is due to be held outside, but a sudden change in weather prevents this from occurring, or does not allow a named Supplier to provide the set up agreed, then the service may have to be moved inside if applicable, no action can be taken against the Suppliers in this circumstance. In cases of adverse weather we will remain in contact with the wedding planner and venue in the lead up to the wedding and we will discuss a contingency plan.

1.39 For clarity, a *force majeure* "event" includes any act, event, non-occurrence, omission or accident beyond our reasonable control or the reasonable control of any of the Suppliers and includes, in particular (without limitation), the following: strikes, lock-outs or other industrial action; or civil commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war; or fire, explosion, storm, flood, adverse weather conditions, earthquake, subsidence, sudden ill health, epidemic, pandemic or other natural disaster; or impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport; or impossibility of the use of public or private telecommunications networks; or change of any law or government policy.

1.40 Our obligations under these terms will be suspended for the period of any "event", and we will notify you as soon as is reasonably possible to advise you of this suspension. Any time limits will be extended accordingly. We will inform you when that "event" is over and extend the time to perform these obligations for the duration of that period. We will take reasonable steps to bring the "event" to a close or to find an alternative solution by which our obligations to give you your wedding day under these terms can be performed despite the "event".

1.41 If the winning couple decides to cancel the wedding then any reasonably foreseeable fees already paid by the Sussex Wedding Team for the cost of any service or item may be collected from the winning couple by the Suppliers to ensure that no Supplier suffers a resultant financial loss.

1.42 If the Government or local government take steps to restrict the movement or assembly of people due to any communicable illness, infection, or other condition of any kind, **our priority must be public health and safety**. Therefore, the Sussex Wedding Team will not be able to attend your wedding, if to do so would put us in violation of any law, official issued advice or other orders which could invalidate any insurances held. In the event of a postponement of the wedding (only due to restrictions issued by the Government or local government) the Sussex Wedding Team will endeavor to change your date of booking where possible to your alternative date. Where an alternative date cannot be guaranteed or achieved where reasonable steps have been taken to find such alternative date, the Suppliers unable to therefore provide their services are indemnified from any claims and all financial responsibility arising from postponement or cancellation.

1.43 If one or both of the winning couple, significant guest or Supplier is advised or instructed to self-isolate due to having or having been exposed to any communicable illness, infection, or other similar condition whatsoever that may be then the above terms and conditions in clauses 1.37 to 1.42 will apply.

1.44 It is the responsibility of the winning couple to inform the Sussex Wedding Team if any party and or guest at the wedding has been informed to self-isolate so appropriate consideration can be taken on how to safely proceed with the wedding.

- 1.45 Any Supplier involved reserves the right to withdraw services up to the Announcement Date. Terms specific to each Supplier are available on request at any time before the Closing Date and must be agreed to by the winning couple before the Suppliers' services and inclusion in the wedding can be confirmed.
- 1.46 The Sussex Wedding Team reserve the right to extend or modify the Closing Date at our discretion or modify the terms as appropriate at any time as other Suppliers offer services or circumstances change.
- 1.47 If any part of these terms and conditions is invalid or unenforceable, the remainder is valid and remains enforced.
- 1.48 Privacy: The Sussex Wedding Team will only process your personal information as set out in the PRIVACY POLICY.
- 1.49 Your details will not be used by the Sussex Wedding Team Suppliers for marketing purposes once the competition has closed however you may **opt in** to any direct marketing material from our named Suppliers when you complete the online form. Your personal details will not be shared with anyone outside of the Sussex Wedding Team.
- 1.50 If there is any reason to believe that there has been a breach of these terms and conditions, the Sussex Wedding Team may, at its sole discretion, reserve the right to exclude you from participating in the Competition.
- 1.51 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
